Do you have any ideas or a plan to help with the current negative economic results of the pandemic and how would you implement?

Property taxes fund Cumberland county expenditures such as : county schools, FTCC, Cape Fear Valley Hospital, Health Dept., Dept. of Social Services, Sheriff's Dept., county offices and courthouse, etc. Property values CAN NOT DECREASE.

Immediately - - no property tax increase - suspend all tax foreclosures - defer/waive 2020 taxes

If elected, how would you resolve any water issues (i.e. Gen X) or future water contamination in your County? How do you safe guard clean water?

My goal is to provide county-wide water. The first step to Grays Creek has been funded. We will continue to discuss options with PWC, Chemours, and the State. Toxic limits must be placed AND ENFORCED by the State of NC and Federal government.

Enforcement is a state and federal duty. We can assist, but no power to make state or federal laws.

(this question only applies to Cumberland County) Now that Cumberland County is considered a Tier 1 status, what grants would you propose applying for?

- 1. Grant from Dept. of Info. Tech., Rural Broadband Program - to expand broadband to rural areas - \$ 2 million available. - only tier 1 can apply.*
- 2. Public Instruction, Needs-based Capital Fund - to assist with school building - only tier 1 and 2 can apply.*
- 3. Funds for small MPOs and RPOs to assist highway projects- only tier 1 and 2 can apply*
